Send this form to P&F at archibus@uq.edu.au and ask to be added to **Health & Safety module** in Archibus. Health and Safety area in Archibus system the following information:

- The Health, Safety and Wellness dashboard
- Access to update safety staff (emergency wardens, first aid officers (including unpaid and paid first officers, safety coordinators) against the buildings their Org Units occupy.
- Access to view building emergency information including reports and evacuation diagrams.
- Hazardous rooms information.
- Building contacts and communications.

iAuditor (access only needed if you plan to undertake workplace inspections, or workstation assessments in the next few weeks)

- b) the name of your Organisational Unit; and
- c) the name of your Faculty/Institute/Division/Centre.

UniFi
